

The Commission has experienced problems in the past with lobbyist's disclosure forms being attached to the lobbyist's principal disclosure form to comply with the disclosure. **Please do not attach copies of your lobbyist's disclosure forms to the lobbyist's principal disclosure form as a means of disclosure.** Just submit the completed lobbyist's principal disclosure form.

Any lobbyist's principal resigning must file a completed disclosure form after employment of all registered lobbyists has been terminated. In addition, a letter notifying this agency of such resignation or termination must also be provided within fifteen (15) days of such termination.

By separate mailing, we are providing copies of the Lobbyist Disclosure Form to all registered lobbyists.
