As you are aware, Section 2-17-25(G) requires a lobbyist's principal to re-register annually prior to January 5. Since you have been registered for 1999 or indicated an interest in registering in 2000, we are providing you with a copy of the Lobbyist's Principal Registration Form. The Lobbyist's Principal Registration Form must be accompanied by \$50. Registration is for a calendar year. Please make checks or money orders payable to the State Ethics Commission. Registrations will not be accepted until December 16, 1999. No lobbyist's principal may re-register in January who has not filed the required disclosure forms for 1999 and paid any late filing penalties, if applicable.

Your lobbyist(s) is also required to register prior to January 5. A separate letter is being sent to each lobbyist currently registered with the Commission to notify them of these re-registration requirements. If you are hiring, employing, or retaining a lobbyist who is not currently registered, please have the lobbyist contact our office for the appropriate registration form or you may contact our office with this information.

Also enclosed is a copy of the Lobbyist's Principal Disclosure Form for those lobbyist's principals who have had any lobbying activity after September 30, 1999. This form is due prior to December 31. If you have had no lobbying activity or nothing else to report since September 30, you are not required to submit this form. Please be aware that all registered lobbyist's principals must submit a disclosure form prior to April 10 for the period of January 1 - March 31 and prior to October 10 for the period of April 1 - September 30. If you terminate your status as a lobbyist's principal at any time throughout the calendar year, a disclosure form must be completed through the last day of registration as a lobbyist's principal. Also, a termination letter must be submitted to this agency of any such termination.

Instructions for completing these forms are printed on the reverse of each form.

Forms may be reproduced, however, the filed copy must contain an original signature and certification. Faxed copies will not be accepted. The original must be received no later than 5:00 p.m. on the date of the established deadline.

Please note that the Commission will assess a late filing penalty of \$100 plus \$10 per day up to a \$600 maximum fine for any forms not received within ten (10) days of an established deadline. Lobbying activity must cease for any lobbyist who has not filed a disclosure and paid any late filing penalties, if applicable.
