Please just submit the completed lobbyist's principal disclosure form.

NOTE: The Commission is authorized to assess a late filing penalty of \$100 plus \$10 per day up to a \$600 maximum fine. Lobbying activity must cease for any lobbyist's principal who has not filed this disclosure and paid any late filing penalties.


Any lobbyist's principal resigning <u>must file</u> a completed disclosure form after employment of all registered lobbyists has been terminated. In addition, a letter notifying this agency of such resignation or termination must also be provided within fifteen (15) days of such termination.
