The Commission is still experiencing problems with lobbyist's disclosure forms being attached to the lobbyist's principal disclosure form to comply with the disclosure. **Please do not attach copies of your lobbyist's disclosure forms to the lobbyist's principal disclosure form as a means of disclosure.** Please just submit the completed lobbyist's principal disclosure form.

NOTE: The Commission is authorized to assess a late filing penalty of \$100 plus \$10 per day up to a \$600 maximum fine. Lobbying activity must cease for any lobbyist's principal who has not filed this disclosure and paid any late filing penalties.

Any lobbyist's principal resigning must file a completed disclosure form after employment of all registered lobbyists has been terminated. In addition, a letter notifying this agency of such resignation or termination must also be provided within fifteen (15) days of such termination.

By separate mailing, we are providing copies of the Lobbyist Disclosure Form to all registered lobbyists.
